Position Summary: The OMD Operations and Policy internship is fantastic opportunity for a student interested in learning the ins and outs of non-profit administration. The intern will gain exposure to all areas under OMD's Operations team, which oversees Finance, Human Resources, Facilities/Technology, and Research.

The Intern will work closely with the Operations team to continuously develop and refine OMD's operations practices, supporting a culture of innovation and impactful use of resources to achieve our mission.

Note that actual duties outlined below may vary depending on the skills, experience, and interest of the intern.

Specific duties and responsibilities include but are not limited to:

Finance

 Keep abreast of updates on non-profit accounting rules and summarize information for leadership

- Prepare and reconcile receipts for expense reimbursement
- Assist with the maintenance of finance files, keeping them organized, accurate, and secure
- Assist with budget tracking
- Liaising with vendors around invoices

HR

- Screen resumes and coordinate candidate interviews
- Assist with new hire staff and intern onboarding process
- Research best-practices and assist in the creation of organizational polices (e.g. expense reimbursement, time-off)
- Assist with compensatory time off tracking
- Author staff newsletter

Facilities and Technology

- Managing the flow of calls and visitors to OMD
- Supply ordering and inventory maintenance
- Organizing the office
- Setting up computers for new employee (guided by IT)

Research

- Fielding and analyzing surveys of OMD stakeholders (students, coaches, staff, college partners)
- Analyzing student data in order to report outcomes

- Coursework in accounting, human resources, data, policy, or non-profit administration
- Intermediate or advanced Excel skills
- Familiarity with accounting software is a plus.
